Malawi

Chisomo Children's Home provides food, shelter, relationship building, family reintegration, health and income programmes to youths living on Malawi's streets. Feed the Children (FTC) is proud to support their efforts with VitaMeal, in order to supplement their activities and further expand their services. Following is a letter and story from the Acting Programme Manager:

Hi Bryce (FTC Programme Director),

I hope this e-mail will find you in good health. I write to remind you of the VitaMeal which we eagerly anticipate for distribution to children and their families. At the current time, we have 10 families where children and parents are HIV positive and the VitaMeal we receive helps in supplementing their dietary needs since the ARV (antiretroviral) drugs they take require that one must be well fed for the body to respond to the treatments.

We would like to make an appeal for an increase in the number of VitaMeal packages you allocate to us since by doing so we can effectively reach out to other families. Families are suffering who need our care and support.

Please receive the following story that articulates the change that VitaMeal has brought to the lives of some children and their families. I promise to keep you updated on the impact that VitaMeal has on children and their families.

"WE OWE OUR RECOVERY TO VITAMEAL", TWO SISTERS REVEAL.

Fifteen year old Dorothy Nyalugwe is an orphan who lives with her older sister in Ntakataka, Dedza. We first met her in 2005 when she was barely 12 years old. In 2007, the girl started having frequent malaria attacks. She went to different hospitals but her condition did not improve. We later encouraged her to go for Voluntary Counselling and Testing (VCT) and she tested HIV positive. Since her CD count (immune system test) was already very low she immediately began taking ARV's (Anti Retro Viral drugs). In spite of the ARV's there were a lot of complications, including malnutrition, as her sister could not afford to offer her balanced meals since she was also providing for her own children and Dorothy's younger sibling. Dorothy's face, legs and arms began to swell.

As luck would have it, this was the time when we started receiving VitaMeal from you (FTC). We had already begun providing the family with food but our help was insufficient since it depended on food availability. We struggled to source food for Dorothy, meanwhile she was diagnosed with tuberculosis and was admitted to the hospital for a month. Fortunately, FTC came to our aid by providing us with VitaMeal. Dorothy is one of the children who started benefitting from VitaMeal donations in order to escape from the complications that arise from a lack of food. Her younger sister also turned out to be HIV positive and she is on ARV's too.

The sisters both received VitaMeal and this resulted in a tremendous change in their health status since there was a substantial nutritional boost to their bodies. After receiving VitaMeal donations, Dorothy said "My younger sister and I thank the donors who make it possible for you to have the VitaMeal that you in turn give to us. I don't know what my sister and I would have done without the VitaMeal you provide."

China

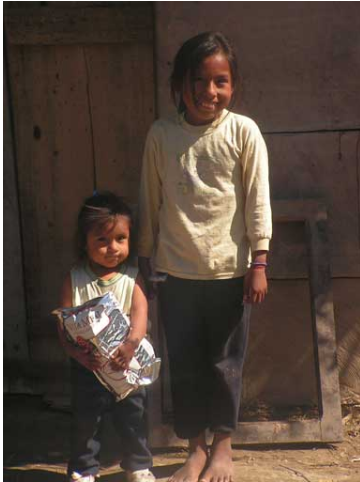
Nu Skin[®] China, finalist for a 2008 Corporate Social Responsibility Partnership Award

At the AmCham Shanghai 4th Annual Corporate Social Responsibility (CSR) Conference and Awards Ceremony, held on 30 October, 2008, Nu Skin[®](China) together with the World Children Fund became one of the seven finalists for the **2008 AmCham Shanghai Corporate Social Responsibility Partnership Award** for their efforts in promoting the Nourish the Children (NTC) initiative in China. The 2008 CSR winners and finalists were selected from a strong field of 50 projects and 37 companies. The evaluation focused on the effectiveness in managing CSR programmes and partnerships.

VitaMeal donors have provided more than 18,000,000 meals to nourish the children of China. These donations have helped handicapped children, victims of earthquake, blizzards and cyclones, and families mired in poverty. China is such a large country that it is very difficult and costly to transport donations to the places that need it most. Our local charity partners, China Foundation for Poverty Alleviation and China Child and Teenager Fund, do not have sufficient budget to cover this transportation. World Children's Fund (WCF) stepped-in to cover the cost of transporting VitaMeal donations from our Jixi plant in Northern China to local charity offices in cities across the land. It is only by working together as partners that NTC and WCF are able to nourish thousands of needy children. Generally, these donations are distributed through schools where nourished children are better able to learn and prepare for a happy and successful future.

Bolivia

SAN JUAN DE YAPACANI



These two girls live in a small community four hours from Santa Cruz in the municipality San Juan de Yapacani. Their parents work in the rice fields and their house is made from mud and wood. During the last two years their house was flooded by the river and their rice plants died.



They have several brothers and sisters and the whole family lives together. The children go to a public school and many times they attended class without eating

breakfast. Thanks to the school feeding programme offered by FTC these children receive a good, warm meal from their mother before going to school. Their mother received training on how to prepare the food. Now she also knows what other foods to combine with VitaMeal that will give the greatest benefit to their bodies.
